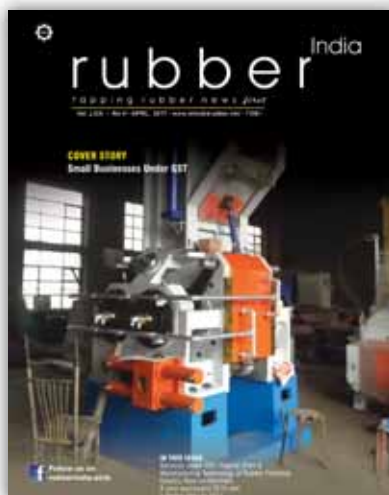

Small Businesses Under GST



Under existing tax law, assessee is required to submit two half-yearly returns under service tax, monthly /quarterly return under excise and quarterly returns under VAT laws in a year. Model GST law .

Services Under GST Regime (Part-I)



The tax on services was introduced in India in 1994 with levy of Service Tax @ 5% on just three services which grew to over 120 services by 2012. It was in July, 2012 that India moved to negative list approach to levy Service Tax on all services except those which are covered in negative list or are specifically exempt.
