Rice Milling Rubber Rollers- Import of Exemption under Notification No. 1212012-C.E. - Eligibility - Said Notification grants exemption from additional Customs duty payable on imported items falling under classification Chapter 84 of Customs Tariff Act, 1975 whereas impugned imported items classifiable under Heading 40.16 ibid - Assessee not eligible to exemption thereunder.
